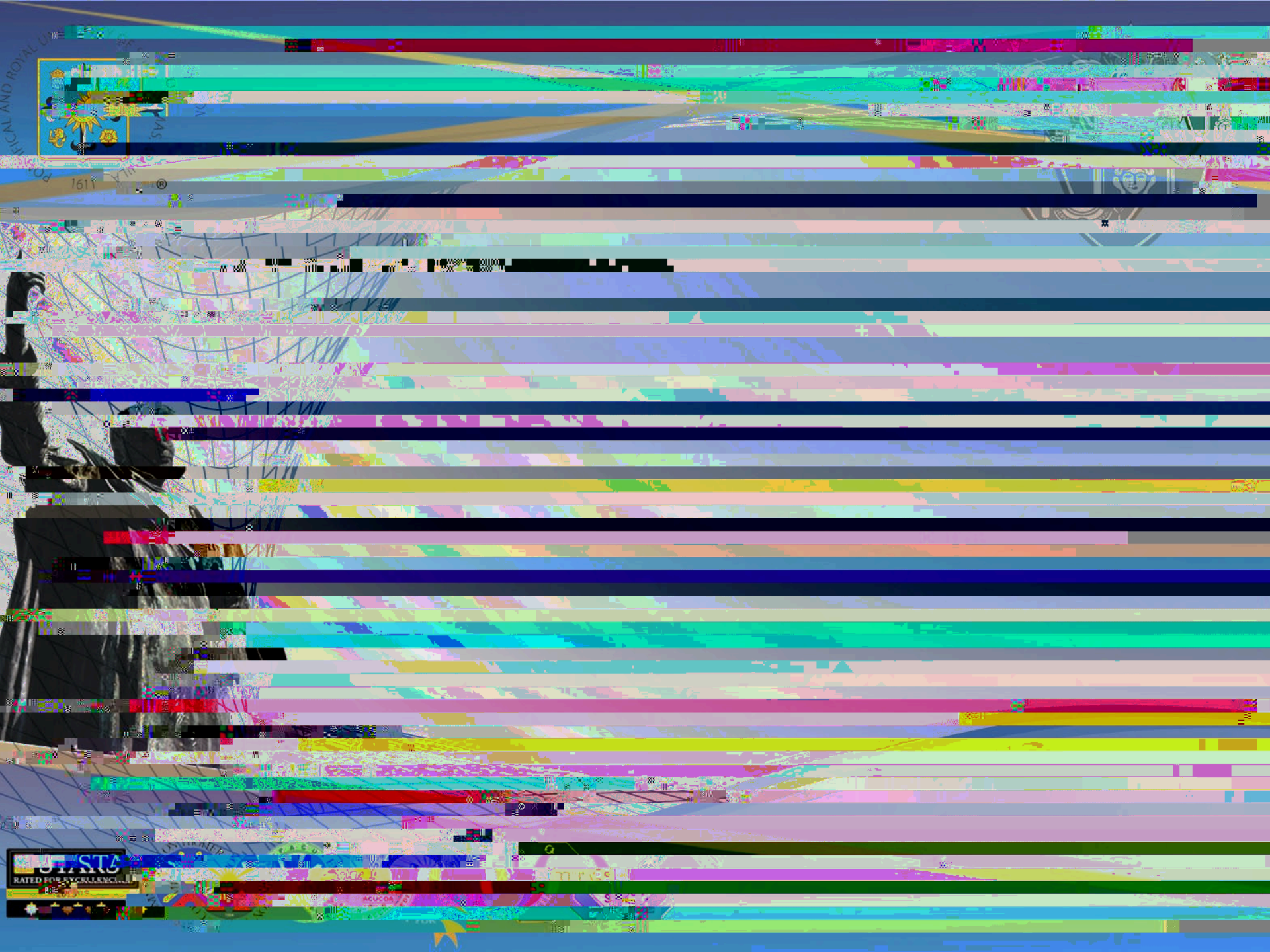
- v. Three percent of tardiness shall be counted.
- vi. Every student is required to attend the required hours to earn the corresponding credits. The allowed absence shall not exceed the required hours.
- vii. In consideration of extenuating circumstances that may be related to life, employment or personal challenges, absences due to illness, classes missed due to late enrollment or late financial payment shall not be counted as the absence. However, students shall be held accountable with missed requirements.
- viii. A student who is absent for an extended period of time shall be considered as a "Drop Out" and shall be required to re-enroll in the next semester.
- ix. For reasons deemed appropriate by the faculty, a student may be granted a possible re-consideration.

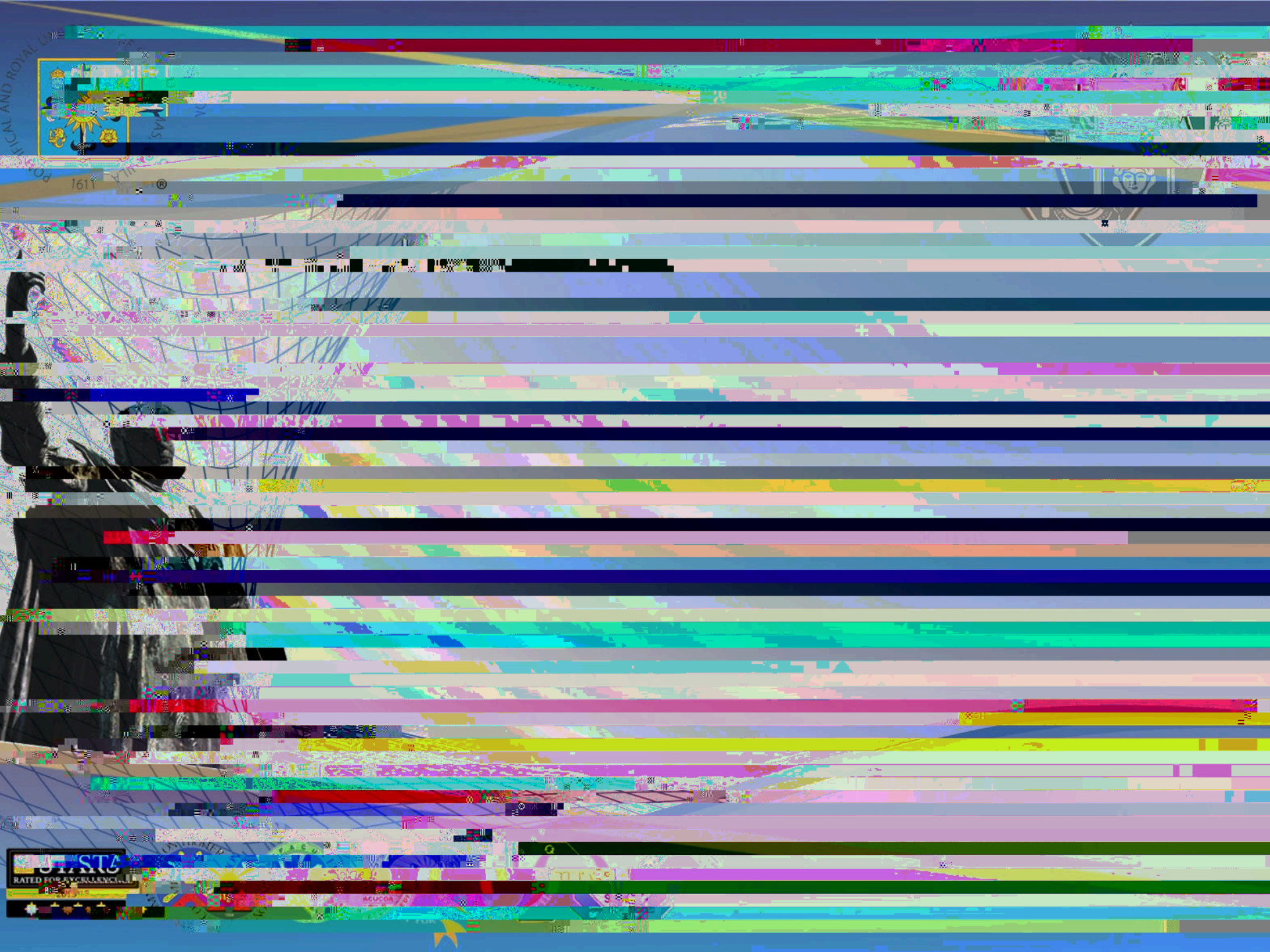

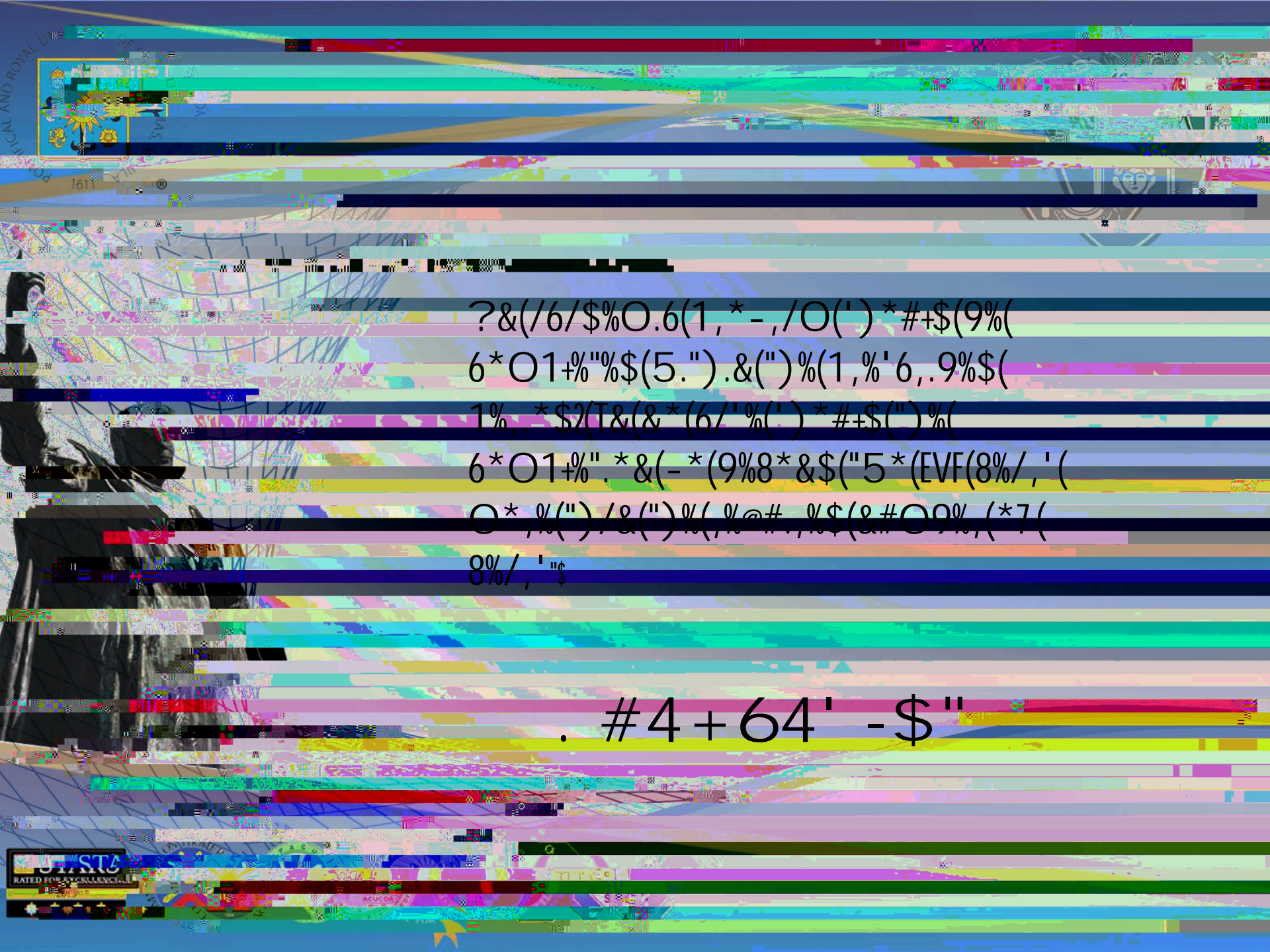

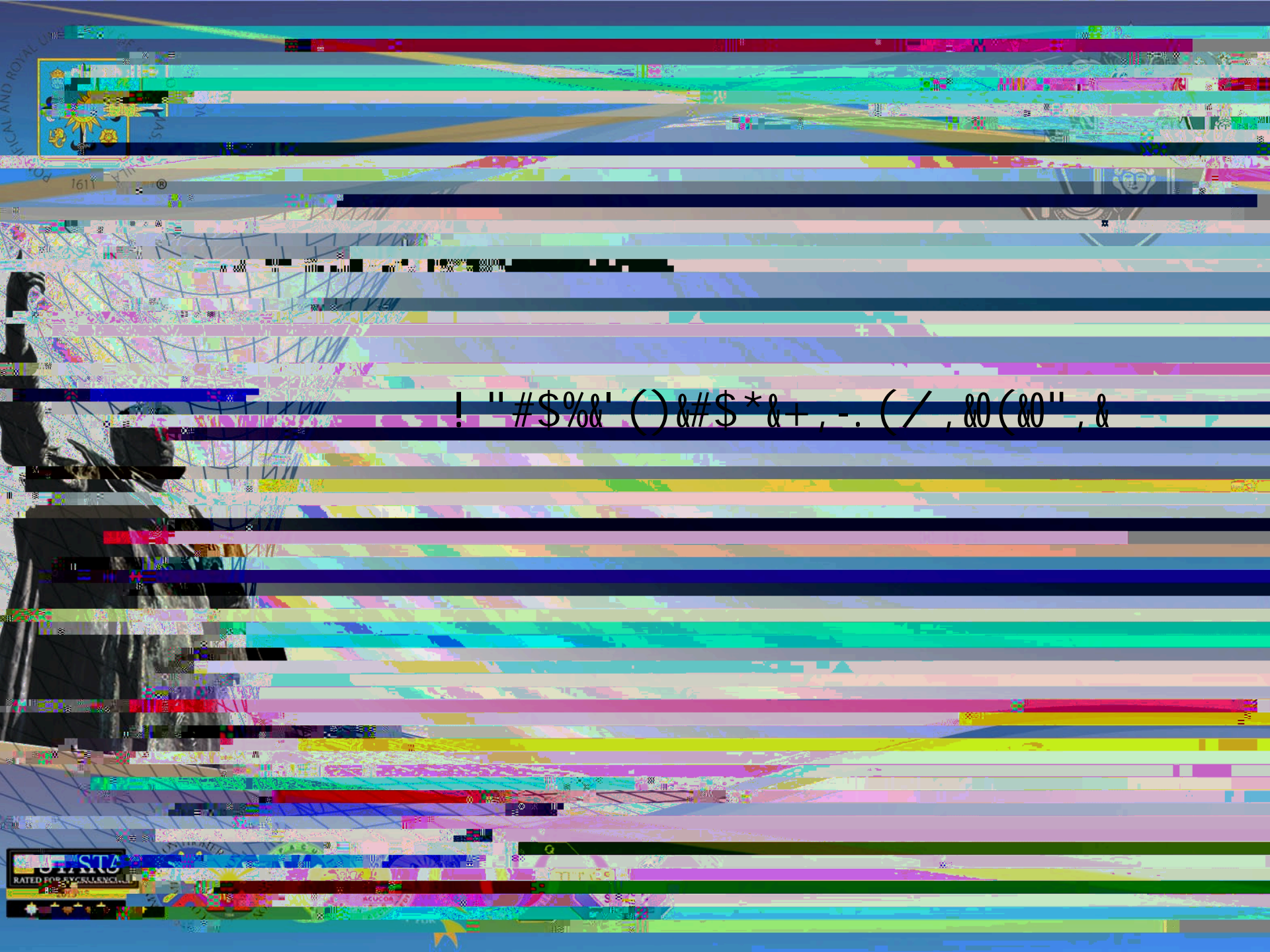
